Inappropriate use is a violation of the AHSJ Honor Code.

I have examined the electronic device identified below ("Equipment"), tested it with the teacher upon delivery and find it to be in good working condition. I understand that the Equipment, like textbooks, is instructional material, and that I am legally responsible for the replacement cost of the Equipment if it is lost, stolen, or damaged while in my possession. I agree to return the Equipment to American Heritage of South Jordan at the end of the school year.

- I understand that no insurance is available for a lost or stolen electronic device and that I am 100% responsible for the replacement cost, payable to American Heritage of South Jordan within 5 business days.

Insurance is available for purchase through American Heritage of South Jordan for accidental damage to the Equipment. Please select one:

- I elect to purchase insurance through American Heritage to cover accidental damage at an annual cost of forty dollars (\$40.00) for tablets and seventy-five dollars (\$75.00) for laptops, which must be by check or money order made payable to American Heritage and delivered to the office prior to the delivery of the Equipment. The insurance shall provide for full replacement subject to exclusions and a \$40 deductible per replacement. Exclusions are as follows:
  1. Neglect, abuse or intentional damage;
  2. any intentional, dishonest, fraudulent or criminal act which results in damage;
  3. inappropriate use as defined by the AHSJ Honor Code; and
  4. any damage that is covered by other insurance. No more than two electronic devices will be provided to a student during any one school year.
- I hereby refuse American Heritage insurance and acknowledge that I must pay the replacement cost of the Equipment if it is damaged.

IN THE EVENT THE EQUIPMENT ASSIGNED TO THE STUDENT IS LOST, STOLEN, OR DAMAGED BEYOND USE, AMERICAN HERITAGE RESERVES THE RIGHT TO ELECTRONICALLY DISABLE THE DEVICE SO THAT IT CANNOT BE USED BY ANY PARTY. FURTHER, AMERICAN HERITAGE RESERVES THE RIGHT TO DISABLE THE EQUIPMENT IF IT IS DISCOVERED THAT IT IS BEING USED FOR INAPPROPRIATE PURPOSES SUCH AS ACCESSING INAPPROPRIATE MATERIAL THROUGH THE EQUIPMENT'S INTERNET CONNECTION.

- Equipment Guidelines and Internet Usage:
  - a. I understand that the above equipment is the property of the AHSJ, and I have a duty to safeguard it at all times. I understand that the school will provide a basic cover if I choose not to provide my own.
  - b. I understand that surge protection is required on any electrical equipment and I am responsible for using this protection.
  - c. I agree to use the equipment for school purposes, and understand that I will be responsible for injury or damages caused by any inappropriate use or unauthorized use of this equipment.
  - d. I understand that any book, music, or application downloaded to the device is done through AHSJ.
  - e. I understand that AHSJ teachers or administrators will randomly check devices for inappropriate internet usage or downloads, and disciplinary action may be taken.
